

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE SURETY LIFE INSURANCE COMPANY, a South Carolina corporation:

All that piece, parcel or tract of land, with the improvements thereon, consisting of 3.24 acres, situate, lying and being near Travelers Rest in the County of Greenville, State of South Carolina, and known and designated as a portion of Tract 7 on a plat entitled "Property of A. J. Green Estate", made by W. J. Riddle, August 18, 1938, and recorded in the R. M. C. Office for Greenville County in Plat Book J at Page 35 and having according to a plat entitled "Survey for Surety Life Insurance Co., Greenville County, S. BEGINNING at an iron pin in the line of property of the grantee herein at the corner of property of John Henry McDaniel, Jr. and Alvin G. McDaniel and running thence with the line of said McDaniel property (Tract 8 of the aforementioned Green Estate) N. 30-03 W. 301 feet to an iron pin; thence with the line of other property of the grantor herein N. 69-19 E. 756.2 feet to a point in the center line of a road, which point is N. 69-19 E. 17.5 feet from an iron pin at or near the Western line of said road; thence with the center line of said road S. 1-40 E. 100 feet to a point in the line of property of the grantee herein; thence with the line of property of the grantee herein S. 52-32 W. 705.6 feet to an iron pin, the point of beginning.
