

ALL that piece, parcel or tract of land, with all buildings and improvements thereon, in Saluda Township, Greenville County, State of South Carolina, containing 53.5 acres, more or less, according to a plat thereof made by J. Mac Richardson, R.L.S., September, 1944, and having according to said plat the following metes and bounds:

BEGINNING at a stone on the West side of Old Greenville-Henderson-ville Road at the Edwards-Ballenger corner and running thence along the line of property now or formerly of Ballenger, N. 43 W., 561 feet to a stone; thence still with property now or formerly of Ballenger, S. 55-30 W., 1120 feet to a stone; thence S. 11 E., 1430 feet to a stone on the North side of U. S. Highway No. 25 and Fall Creek and running parallel to said U. S. Highway No. 25, N. 70 W., 1145 feet to a point at a culvert; thence along and with U. S. Highway No. 25, as follows: N. 69-45 W., 150 feet to a curve 12° right, 566.4 feet and N. 1-45 W., 532.1 feet; thence a 10° curve right, 108.3 feet crossing a drive to an iron pin; thence along the line of property now or formerly of Carolina Lake Colony and crossing Fall Creek, N. 73-35 E., 1112 feet more or less, to an iron pin at the top of ridge; thence still with property now or formerly of Carolina Lake Colony, N. 55-30 E., 1120 feet to an iron pin on the West side of the Old Greenville-Hendersonville Road; thence along the Western side of said Road, S. 18-19 E., 101 feet to a point; thence still with the Road, S. 24-24 E., 270.8 feet to a point; thence still with the Road, S. 28 E., 70.2 feet to a point; thence still with the Road, S. 28 E., 70.2 feet to a point; thence S. 38-51 E., 552.8 feet to a stone, the point of beginning.
