

All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being known and designated as lot No. 2, on plat of Liberty Park, recorded in plat book EE page 145 of the R. M. C. Office for Greenville County, S. C., and having according to a recent survey made March 1956, by R. W. Dalton, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the south side of Edwards Road, the front joint corner of Lots 1 and 2; thence with the joint line of said lots S. 0-43 W. 189.7 feet to an iron pin in line of Lot No. 3; thence with the line of said lot, S. 89-17 E. 90 feet to an iron pin on the west side of Proffitt Drive; thence with the west side of said Proffitt Drive, N. 0-43 E. 170 feet to an iron pin; thence with the curve of said street as it intersects with Edwards Road, the chard of which the curve of said street as it intersects with Edwards Road, the chord of which is N. 45-57 W. 34.3 feet to an iron pin on the south side of Edwards Road; thence with the south side of said Edwards Road S. 87-21 W. 65 feet to the beginning corner.
