in consideration of the sum of One Hundred Twenty-two and No/100--- in the State aforesaid, DOLLARS.

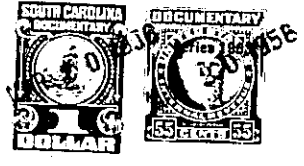
