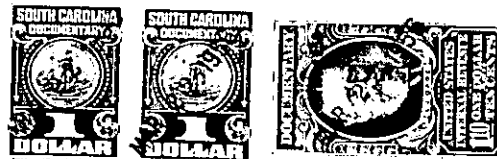
That We, Edward L. Dobson and Frances M. Dobson
