

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE CITY OF GREEN VILLE, SOUTH CAROLINA, its successors and assigns, forever:
All that piece, parcel or tract of land with all buildings and improvements thereon, situate, lying and being in Saluda Township, Greenville County, South Carolina, and having the following description:

BEGINNING on a sourwood stump on the East side of the State Road and running thence N. 50 E. 48 poles to a sourwood stump; thence N. 5 E. 80 poles to a chestnut; then ce N.542 E. 592 poles to a rock in the John Ward line; thence with said line S. 58 E. 146 poles to a white oak at Louis Davis' corner; thence with his line S. 9 W. 42 poles to a sourwood, his corner; thence with his other line S. 39 E. 25 poles to a chestnut oak stump, his corner; thence still with the said Davis line S. 6 E. 14 poles to a stake in Joe Revis' line; thence N. 842 W. 2 poles to a locust stump; thence N.  $77\frac{1}{2}$  W. 28 poles to a hickory; thence S. 62 W. 16 poles to a spanish oak; thence S. 18 W. 32 poles to a small poplar; thence S. 5 W. 26 poles to a stake; thence S. 60 W. 4 poles to a chestnut oak; thence N. 81 W. 27 poles to a hickory, Alfred Ward's old corner; thence N. 80 W. with the said Ward line 60 poles to a sourwood by a large chestnut stump; thence N. 55 W. 60 poles to a persimmon tree on the East bank of the said Road; thence with the said Road 17 poles to the beginning corner, containing 184 acres, more or less, and being the same property conveyed to the Grantors herein by deed of Alfred Ward, dated April 11, 1919, recorded in the R.
