in consideration of the sum of Five Hundred Seventy Nine and 60/100 - - - - - in the State aforesaid, DOLLARS,

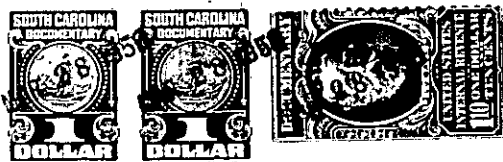
