That I, JAMES W. LASTER in the State aforesaid, in consideration of the sum of Eight Hundred Fifty-seven and No/100----- DOLLARS,

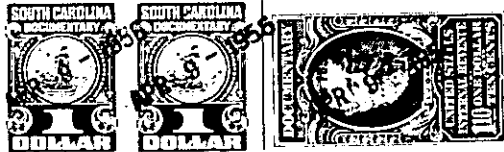
