That GLYNN A. LINDSEY in consideration of the sum of FOUR HUNDRED & NO/100- - - - - DOLLARS, in the State aforesaid,

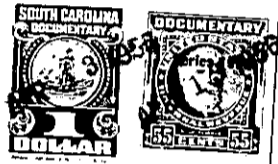
