

BEGINNING at an iron pin on the South side of High Valley Boulevard at joint front corner of Lots 9-A and 9-B, said pin also being 363.4 feet in an Easterly direction from the Southeast corner of the intersection of High Valley Boulevard and Old Grove Road, and running thence along the South side of High Valley Boulevard, S. 57-53 E. 25.8 feet to an iron pin; thence continuing with High Valley Boulevard S. 43-50 E. 125 feet to an iron pin; thence S. 25-10 W. 93.3 feet to an iron pin; thence S. 75-54 W. 79.9 feet to an iron pin; thence S. 55-04 W. 45.5 feet to an iron pin at corner of Lot 9-A; thence with the line of Lot 9-A, N. 10-32 E. 242 feet to an iron pin on the South side of High Valley Boulevard, the beginning corner.
