OLLIE FARR R.M.C. Knows All Men by These Presents:

That I, Carl B. Holland, of Greenville County, in the State aforesaid, in consideration of the sum of One Thousand, Three Hundred and No/100 - - - - - DOLLARS, and the assumption of mortgage set out below

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantees, Clyde Cofield and Wilma B. Cofield, their heirs and assigns forever:

All that piece, parcel, or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, lying and being on the southeast side of Putman Road, being known and designated as Lot No. 3 of the property of J. K. Keller as shown on a plat thereof prepared by W. J. Riddle, Surveyor, dated April, 1948 and recorded in the R.M.C. office for Greenville County in Plat Book U, at page 97. Said property being a re-subdivision of the greater portion of Lots Nos. 23 and 24 of the Farr Estates subdivision shown on a plat thereof recorded in Plat Book M, at page 19, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Putman Road, which iron pin is 345 feet, more or less, from the intersection of Putman Road and Farr Road, and at the joint front corner of Lots 22 and 23 of Farr Estates, and running thence along the line of Lot No. 22, S. 28-15 E. 330 feet to an iron pin 10 feet N. 28-15 W. from the center of a branch; thence in an easterly direction in a line 10 feet from and parallel with the meanderings of said branch, 300 feet to an iron pin; thence S. 30-30 E. 10 feet to a point in the center of said branch; thence along the meanderings of said branch in an easterly direction 100 feet to an iron pin, joint rear corner of Lots 24 and 25 of Farr Estates; thence N. 30-30 W. 180.6 feet to an iron pin, joint corner of Lots 2 and 3, J.K. Keller property; thence N. 74-05 W. 315 feet to an iron pin, joint corner of Lots Nos. 2 and 3; thence S. 77-16 W. 85 feet to an iron pin on Putman Road, joint front corner of Lots 2 and 3; thence with Putman Road, S. 8-10 W. 39 feet to an iron pin; thence still with Putman Road, S. 23-30 W. 85 feet to the beginning corner; being the same conveyed to me by L.B. King by deed dated February 9, 1956 and recorded in the R.M.C. office for Greenville County in Vol. 545, page 305.

The grantees assume and agree to pay that certain note and mortgage executed by the grantor in favor of Carolina Federal Savings and Loan Association in the sum of \$4700.00.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

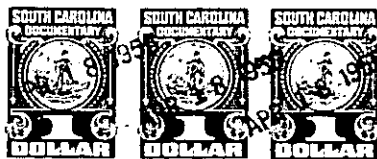
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.
