Billy H. Forrester, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being on the . northwestern side of Bleckley Avenue in Butler Township, Greenville County, State of South Carolina and being known and designated as Lot No. 4 and the northern half of Lot No. 5, Block F of Fair Heights as shown on plat thereof prepared by R. E. Dalton dated October, 1924 and having the following metes and bounds, to-wit:



BEGINNING at an iron pin on the northwestern side of Bleckley Avenue. joint front corner of Lots Nos. 3 and 4 and running thence along said Avenue, S. 31-20 W. 75 feet to a point in the front line of Lot No. 5; thence through the center of Lot No. 5, N. 58-40 W. 150 feet to a point in the rear line of Lot No. 5; thence N. 31-20 E. 75 feet to an iron pin, joint rear corner of Lots Nos. 3 and 4; thence along the joint side line of said lots, S. 58-40 E. 150 feet to the beginning corner.
