All that piece, parcel or lot of land within the corporate limits of the City of Greenville, County of Greenville, State of South Carolina, lying and being situate on the Southerly side of Rhett Street, being known and designated as Lot No. 64 according to Plat of Property of Thomas M. Walker, Inc., prepared by Jacobs-Fitzpatrick Company, Engineers, dated August, 1919, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "E", at page 146, and also according to plat recorded in said office in Plat Book "C", at page 265, and having, according to more recent plat, prepared by Dalton & Neves in April, 1955, the following metes and bounds, to-wit:
