

Office for Greenville County, South Carolina, in Plat Book "F" at page 257, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Cumberland Avenue, joint front corner of Lots 8 and 9, and running thence along the joint line of said Lots, N. 58-40 W. 140 feet to an iron pin, joint rear corner of Lots 8, 9, 15 and 14; thence along the line of Lot No. 14, S. 31-20 W. 50 feet to an iron pin, joint rear corner of Lots 9, 10, 14 and 13; thence with the joint line of Lots 9 and 10, S. 58-40 E. 140 feet to a pin on the Northwestern side of Cumberland Avenue; thence along Cumberland Avenue, N. 31-20 E. 50 feet to the beginning corner.
