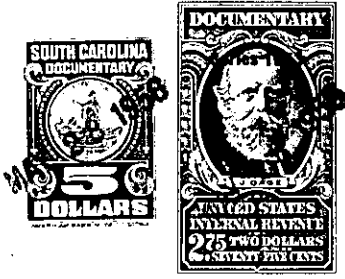

ROBERT W. RAMSAY, his heirs and assigns, forever:

ALL that lot of land, situate on the West side of Stratford Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 115 on Plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the RMC Office for Greenville County, S. C. in Plat Book "GG", page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Stratford Road at joint front corner of Lots 114 and 115 and running thence with the line of Lot 114 S. 71-44 W. 150 feet to an iron pin; thence S. 14-45 E. 82.4 feet to an iron pin; thence with the line of Lot 116 N. 71-44 E. 155.1 feet to an iron pin on the West side of Stratford Road; thence with the West side of Stratford Road N. 14-02 W. 82.2 feet to the beginning corner.

ALSO all that lot of land, situate on the West side of Stratford Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 117 on Plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the RMC Office for Greenville County, S. C. in Plat Book "GG", page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Stratford Road at joint front corner of Lots 116 and 117 and running thence with the line of Lot 116 S. 71-44 W. 160 feet to an iron pin; thence S. 14-45 E. 80.2 feet to an iron pin; thence with the line of Lot 118 N. 71-44 E. 164.9 feet to an iron pin on the West side of Stratford Road; thence with the West side of Stratford Road N. 18-10 W. 80 feet to the beginning corner.

This property is conveyed subject to the restrictions applicable to South Forest Estates, which are recorded in the RMC Office for Greenville County, S. C., in Deed Book 547, at Page 60.

The above property is a portion of the tracts of land lying South of Fairfield Road which were conveyed to the Grantors by deed of Eula Croft Valentine, dated January 1, 1955, recorded in the RMC Office for Greenville County, S.
