

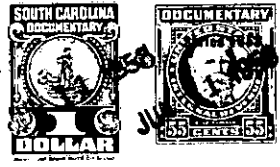

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Wilbur A. Jackson, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, School District 6-D, being known and designated as Lot No. 115, of a subdivision of Conestee Mill Village as shown on plat thereof made by R.E. Dalton in December, 1943 and recorded in the R.M.C. Office for Greenville County in Plat Book K, at page 276, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Fourth Street at the corner of Lot No. 114, which point is 200 feet Northeast of the intersection of Second Avenue, and running thence along the Southeast side of Fourth Street, N. 35-11 E. 105 feet to an iron pin at the corner of Lot No. 116; thence along the line of Lot No. 116, S. 54-49 E. 150 ft. to an iron pin in line of Lot No. 153; thence along the line of said Lot No. 153, S. 35-11 W. 105 ft. to an iron pin at the rear corner of Lot No. 114; thence along the line of said Lot No. 114, N. 54-49 W. 150 feet to the beginning corner.

The above described property is the same conveyed to the Grantor herein by Berdie Neomia Fowler by deed dated September 10th, 1953 and recorded in said RMC Office in Book 488 Page 67.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.
