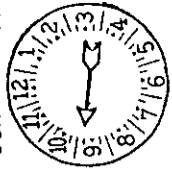

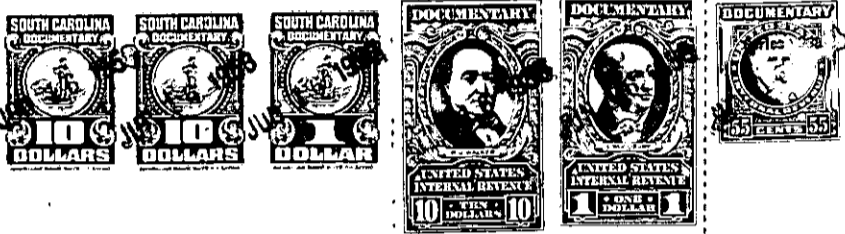
Now All Men by These Presents:

That I, F.L. Crow in consideration of the sum of Ten Thousand Five Hundred (\$10,500.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Samuel F. Stack and Mary B. Stack and their heirs and assigns forever:

All of those parcels or lots of land in the City of Greer, in Chick Springs Township of Greenville County, South Carolina, lying on the East side of Piedmont Avenue, known as Lots Nos. 57 and 58 on a plat of property known as "Morrow Park," which plat is on record in the R.M.C. Office for Greenville County in Plat Book "E", at page 91, and having the following courses and distances:

BEGINNING at an iron pin on the East side of Piedmont Avenue-Now Memorial Drive-joint corner of Lots Nos. 56 and 57, and runs thence with the common line of these two lots S. 78 E. 139 feet to a stake; thence S. 11.30 W. 60 feet to a stake; thence N. 78 W. 138.5 feet to a stake on the East side of Memorial Drive-formerly Piedmont Avenue; thence with the East side of Memorial Drive N. 10.30 E. 60 feet to the beginning corner, and being the identical property conveyed to the grantor by Sam E. Frey, Jr. and Evelyn H. Frey by deed dated May 18, 1955 and recorded in the R.M.C. Office for Greenville County in Deed Book 525, at page 540.
