That JESSIE W. CHILDERS in the State aforesaid, in consideration of the sum of ONE THOUSAND TWO HUNDRED AND NO/100 (\$1,200.00) - - - - -DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ABNER B. MORRELL, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 5, Bramlett Park, Property of Jessie W. Childers, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 113, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeasterly side of Pendleton Road, joint front corner Lots 4 and 5, and running thence N. 28-30 E. 180 feet to an iron pin, joint rear corner Lots 4 and 5; thence N. 58-30 W. 85 feet to an iron pin, joint rear corner Lots 5 and 6; thence S. 28-30 W. 180 feet to an iron pin on the Northeasterly side of Pendleton Road, joint front corner Lots 5 and 6; thence along the Northeasterly side of Pendleton Road, S. 58-30 E. 85 feet to an iron pin, the point of beginning.

This property is conveyed subject to the following restrictions: (1) No house shall be built on any of the lots specified with any portion of the house closer than 35 feet to White Horse Road or Pendleton Road. (2) No structure other than residence or any building subservient thereto shall be erected on any of said lots. (3) No residence shall be constructed which contains less than 1,200 square feet in the body of the house. (4) No outside toilet shall be allowed on the premises and all septic tanks and other toilet and sanitary provisions shall be so constructed as to meet minimum sanitary requirements. (5) Should any of the above restrictions be held illegal, this shall not nullify the effect of the others.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
