Strange land, then continueing with the same course for a total distance of 707 feet to an old iron pin in gully, Marie M. Strange corner; thence N. 89-08 W. 397.3 feet to an old iron pin, Marie M. Strange corner; thence following the spring branch as the line (the line being in the back water of a pond) N. 86-54 W. 300 feet to an angle; thence N. 78-17 W. 79 feet to an angle; thence S. 80-09 W. 264 feet to a point in pond; there with the common line of tracts 3 and 4, S. 15-00 E. 18 feet to an iron pin, then continueing with the same course for a total distance of 1101 feet to an iron pin in a water way, joint corner of tracts 3 and 4 and on the C. C. McGowan, Jr. line; thence with the Waterway and the McGowan line S. 74-30 E. 702 feet to an iron pin, joint corner of the McGowan tract and on the former B. L. Smith Estate line; thence with this line, N. 4-00 E. 310.5 feet to an iron pin, Smith corner; thence with another Smith line, S. 87-20 E. 327 feet to an iron pin, E. B. Mason corner and on the Smith line; thence with the rear line of E. B. Mason, N. 0-30 W. 257.8 feet to an iron pin, joint corner of tracts 1 and 3; thence with the common line of tracts 1 and 3, S. 86-18 E. 193 feet to an iron pin on the line of No. 1. and joint corner of Lots Nos 2 and 3; thence with the common line of Lots Nos. 2 and 3, N. 2-52 E. 348 feet to an iron pin in farm road near a tenant house; thence with the said farm road, N. 83-32 E. 346.4 feet to the beginning corner (iron pin back on line at 11.4 feet), containing Thirty Six and Thirty Three One-hundredths (36.33) acres, T20-1-11.1 more or less.
