to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. G. PROFFITT

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 20 of a subdivision known as McSawain Gardens, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book GG at page 75, and having the following metes and bounds to wit:

BEGINNING at a point on the southwestern side of Sharon Drive at the joint front corner of Lots 19 and 20 and running thence with the joint line of said lots, S. 43-40 W., approximately 203.3 feet to a point in branch, the joint rear corner of Lots 19 and 20; thence with said branch as a line approximately N. 44-55 W. approximately 136.9 feet to a point on the southeastern side of a reserved strip of land; thence with the southeastern side of said reserved strip of land N. 42-30 E. approximately 175.9 feet to a point; thence following the curvature of the southwestern intersection of said reserved strip of land with Sharon Drive, the cord of which is N. 89-37 E. 33.8 feet to a point; thence with the southwestern side of Sharon Drive S. 42-42 E. 60.7 feet to a point; thence continuing with the southwestern side of Sharon Drive S. 51-15 E. 55.7 feet to the point of beginning.
