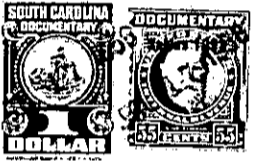

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Willis E. Case her Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township, just outside the corporate limits of the Town of Fountain Inn, in the subdivision known as Woodland Heights, being known and designated as Lot No. 34 of the Lilla H. Jones & Essie Mae H. Jones property on a Plat prepared by Lewis C. Godsey, Surveyor, in May 1954, said Plat of record in the Office of the R. M. C. for Greenville County, S.
