

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Arley E. Owen and Frances L. Owen, their hiers and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot No. 3 of a subdivision known as Bel Aire Estates, as shown by a plat thereof, dated May 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at page 19, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at joint front corners of Lots Nos. 3 and 4, and running thence N. 6-10 W. 52.5 feet to iron pin on Staunton Bridge Road; thence running N. 39-40 E. 27.9 feet to iron pin on Sangamo Drive; thence running with said Drive, N. 85-30 E. 210 feet to iron pin at front corner of Lot 54; thence running with joint line of said lot S. 4-30 E. 72.53 feet to iron pin at rear corner of Lot 4; thence running S. 85-30 W. 227.8 feet to iron pin on Staunton Bridge Road to the point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent; no residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights-of-way of record.

GRANTEE to pay taxes for the year 1956.
