All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 165, Section III, Lake Forest Subdivision, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 77, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Malvern Place, joint front corner Lots 165 and 166, and running thence N. 37-09 W. 248.1 feet to an iron pin, joint rear corner Lots 165 and 166, said iron pin being in the center of a Duke Power Right-of-Way; thence through the said Right-of-Way N. 40-03 E. 8.7 feet to an iron pin; thence continuing through the said Right-of-Way N. 80-12 E. 141.7 feet to an iron pin on Rockmont Road; thence along Rockmont Road S. 50-11 E. 48.2 feet to a point; thence S. 52-16 E. 94.4 feet to a point; thence along the curve of the intersection of Malvern Place and Rockmont Road, the chord of which is: S. 4-47 W. 33.6 feet to a point; thence along Malvern Place S. 43-03 W. 55.3 feet and continuing along Malvern Place S. 48-42 W. 95.6 feet to an iron pin, the point of beginning.
