## CHARTER

BY THE SECRETARY OF STATE

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is GREENVILLE AUTO WRECKING COMPANY, INC.

THIRD: That the principal place of business is Greenville, South Carolina

FOURTH: That the general nature of the business which it is proposed to do is buy, sell, acquire, dispose of, deal and trade in and with, at retail or wholesale, scrapped or wrecked automobiles and any and all other scrap or waste products including metal, industrial wastes, textile fabrics or other articles of any kind or nature; to wreck, demolish, and acquire personal or real property of any kind, for any purpose, including the purpose of salvaging all scrap or waste products; and generally to do any and all things necessary, proper, or convenient for such purposes, including the owning and leasing of such real estate as may be necessary therefor; and generally to do any and all acts and things which a corporation may do under the laws of the State of South Carolina.

FIFTH: That the amount of the capital stock is Three Thousand Six Hundred (\$3,600.00) Dollars payable in money, property, or services.

SIXTH: That the number of shares into which the capital stock is divided is Thirty-six (36)

of the par value of One Hundred (\$100.00) ----- Dollars.
