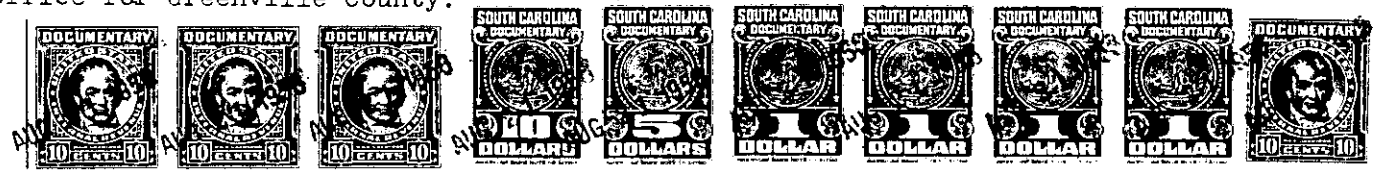
That I, J. H. Mauldin in the State aforesaid,
