to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JOHN CARL MOOREHEAD, JR., his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Southwest side of Pinehurst Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 29, Block B, on plat of Pinehurst, made by W. N. Willis, Engineer, October 28, 1948, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "S", at Page 77, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwest side of Pinehurst Drive, at joint front corner of Lots 27 and 29, and running thence with the line of Lot 27, S 62-23 W, 136.5 feet to an iron pin; thence S 27-37 E, 60 feet to an iron pin; thence with the line of Lot 31, N 62-23 E, 135.6 feet to an iron pin on the Southwest side of Pinehurst Drive; thence with the Southwest side of Pinehurst Drive, N 26-48 W, 60 feet to the beginning corner.
