Evelyn H. Aiken, her heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the easterly side of Whitman Drive, near the Town of Taylors, S. C., being shown as Lot No. 46 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Whitman Drive at a point 367.1 feet north of the northeasterly corner of the intersection of said Drive with Heathwood Drive, said pin being the joint front corner of Lots Nos. 46 and 47, and running thence along the joint line of said lots S 80-06 E 200 feet to an iron pin; thence N 9-54 E 100 feet to an iron pin, joint rear corner of Lots Nos. 45 and 46; thence N 80-06 W 200 feet to an iron pin on the easterly side of Whitman Drive; thence S 9-54 W 100 feet to the point of beginning.
