That I, H. E. FULLER in the State aforesaid, in consideration of the sum of Nine Hundred (\$900.00) - - - - - DOLLARS,

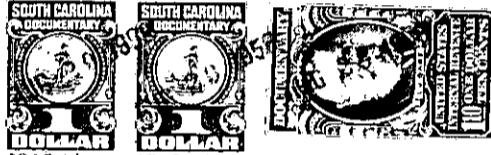

All that certain piece, parcel or lot of land located in Cleveland Township, Greenville County, State of South Carolina, and being known and designated as lot No. 10 according to a Plat of the subdivision of the property of J. L. Johnson, made by J. C. Hill L. S., June 7, 1952, said lot containing 5.7 acres, more or less, and being described according to said Plat as having the following metes and bounds, to-wit:
