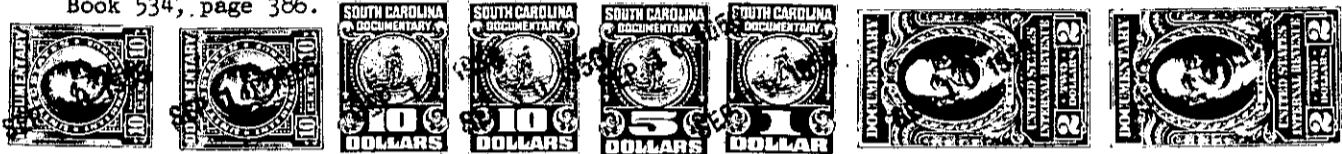
Schaefer B. Kendrick and Harry R. Stephenson, Jr.; their heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the southerly side of East North Street, in the City of Greenville, S. C., being a portion of Lot No. 2, Block 5, Boyce Addition, plat recorded in Deed Book ZZ, page 934, and having according to a survey entitled property of John F. Chandler, et al., made by Dalton & Neves in May, 1952, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of East North Street at a point 100 feet west of the southwesterly corner of the intersection of East North Street and Manly Street, and running thence S 16-07 E 184.7 feet to an iron pin on the northerly side of a 15 foot alley; thence along the northerly side of said alley S 76-0 W 17.83 feet to an iron pin; thence N 16-07 W 184.7 feet to an iron pin on the southerly side of East North Street; thence along the southerly side of East North Street N 76-0 E 17.83 feet to the point of beginning.

This is the same property conveyed to the grantors by the deed recorded in Deed Book 456, page 535.

As part of the consideration hereof the grantees assume and agree to pay the unpaid balance of \$6,003.74 due on that certain mortgage given by the grantors to Fidelity Federal Savings & Loan Association, in the original amount of \$7,700.00, dated July 14, 1952 and recorded in Mortgage Book 534, page 386.
