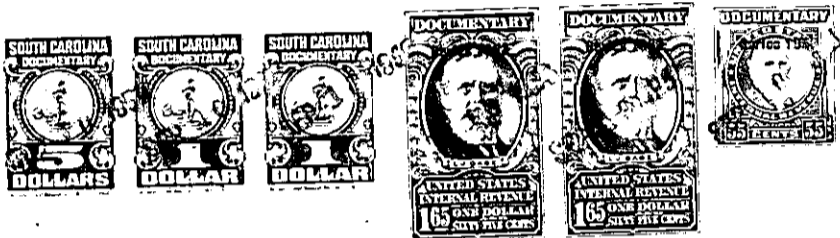

Whitehead,

All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, Chick Springs Township, lying between the Rutherford Road (formerly Base Hospital Road) and Cason Avenue, according to plat made by Terry T. Dill, Surveyor July 25, 1951 of sub-division of lot of A. M. Doggett, and being known as Piedmont Park, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the East side of the Rutherford Road and running S. 45-32 E. 183.6 ft. to an iron pin on Cason Avenue; thence along the North side of Cason Avenue, N. 50-03 E. 104.7 ft. to an iron pin on Cason Avenue; thence N. 58-51 W. 112.7 ft. to an iron pin; thence N. 32-26 E. 51.3 ft. to an iron pin on the property of H. O. Moody; thence along the line of the Moody property, N. 74-39 W. 107.2 ft. to an iron pin on Rutherford Road; thence along the said Rutherford Road, S. 30-09 W. 79 ft. to an iron pin, the beginning corner.
