D. Calmes, Reg. Surveyor, August 18, 1956 (to be recorded herewith), the following metes and bounds, to-wit:

BEGINNING at an iron pin N. 59-10 W. 55 feet from the southwest intersection of Sunrise Drive and an unnamed Drive and running thence S. 30-50 W. 100 feet to an iron pin; thence N. 59-10 W. 65 feet to an iron pin; thence N. 30-50 E. 100 feet to an iron pin on said unnamed Drive; thence S. 59-10 E. 65 feet to point of beginning.

This conveyance is made, however, subject to the following restrictions which are deemed covenants running with the land:

- (1) This property may be used for residential purposes only and no building other than a one-family dwelling may be erected thereon, garage and outbuildings excluded.
- (2) No hotel, inn, boarding house, cafe, restaurant or any type of eating establishment may be erected or operated on these premises.

This property is conveyed subject to any existing rights-of-way or easements for utility purposes.
