That I, S. RUSSELL STOVER in the State aforesaid, in consideration of the sum of Twelve Thousand and No/100----- DOLLARS,

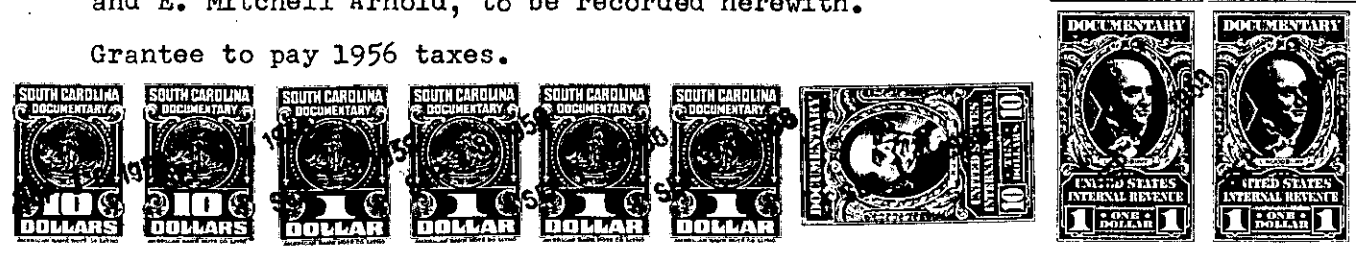
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said EMORY E. BARWICK, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Northeast side of East Circle Avenue, in the City of Greenville, in Greenville County, South Carolina, shown as the Southeastern 30 feet of Lot 18 and the Northwestern 45 feet of Lot 19 of a subdivision known as East Lake on plat thereof, made by Dalton & Neves, Engineers, in Juen, 1928, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "G", at Page 229, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeast side of East Circle Avenue, which iron pin is 30 feet Northwest of the joint front corner of Lots 18 and 19, and running thence a new line through Lot 18, N 37-15 E, 154.35 feet to an iron pin, said pin being 30 feet from the joint rear corner of Lots 18 and 19, and running thence S 53-22 E, 75 feet to an iron pin; running thence a new line through Lot 19, S 37-15 W, 155.3 feet to an iron pin on East Circle Avenue; thence with the said East Circle Avenue, N 52-45 W, 75 feet to the Beginning corner.
