C., adjoining the Fairview Baptist Church property and being known as Lots SIXTEEN (16), SEVENTEEN (17), EIGHTEEN (18) and NINETEEN (19) on plat number ONE (1) of the R. B. Vaughn Estate, made by H. The within described property is conveyed subject to the following restrictions and protective covenants.
