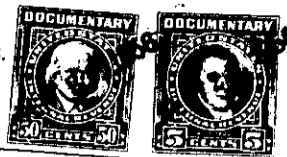

All that lot of land in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as Lot No. 76 on plat of Central Development Corporation recorded in plat book BB pages 22 and 23 of the R.M.C. Office for Greenville County and having according to a recent survey made by R. W. Dalton, May 1954, the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Coventry Lane, the front joint corner of Lots Nos. 75 and 76 and running thence with the joint line of said lots S. 82-32 E. 248.7 feet to an iron pin in rear line of Lot No. 94; thence with the rear line of said lot N. 7-51 E. 40.4 feet to an iron pin rear corner of Lot No. 93; thence with the line of said lot N. 2-30 W. 19.6 feet to an iron pin corner of Lot No. 77; thence with the line of said lot N. 77-45 W. 243.1 feet to an iron pin on the east side of Coventry Lane; thence with the east side of said Street S. 9-48 W. 80 feet to the beginning corner.
