in consideration of the sum of One Hundred Sixty-two and No/100-----(\$162.00)--- in the State aforesaid, DOLLARS,

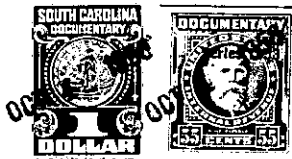
