All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, situate on the northwestern side of Mable Avenue in Chick Springs Township, being shown and designated as Lot 63 on plat of the property of James M. Edwards recorded in Plat Book II at Page 121, and having according to said plat the following metes and bounds:
