the Rachael Lindsey line to a stone 3x; thence with said line to the "Wheeler Hickory" 3x; thence to a white oak, 3x (Hulda Lindsey corner); thence with the branch to an ash 3x; thence with a line of the William Howard tract to a stone 3x; thence to a chestnut 3x; thence with the dividing line to the beginning chestnut.

(27) Those two tracts on Gap Creek of North Saluda River, containing respectively 77 acres and 68 acres, and having the following metes and bounds, respectively, according to two Plats thereof prepared by Will D. Neves, Surveyor, bearing date April 22, 1904:

FIRST: That tract beginning on a white oak 3 x (down) on Gap Creek at the tope of the shoals, and running thence N. 10 E., 3.00 to a poplar 3x om on Portman Howard's corner; thence along the line of Portman Howard land, N. 20 E., 35 chains to a hickory 3x om (gone) on the corner of the Portman Howard land; thence N. 78 E., 21.50 chains to a stone 3x om on or near a ledge of large rocks; thence S. 37 E., along the line of the land of the Harris Pittman land 17.00 chains to a chestnut 3x om (down); thence S. 48 E., along the line of the land of the Timothy Pittman land 6.00 chains to a maple station on Gap Creek, near the "Winds"; thence down said Gap Creek following the meanders thereof to the beginning corner, containing 77 acres, more or less, this tract lying wholly on the West side of Gap Creek.

SECOND: That tract lying on the East bank of Gap Creek, and only separated by said Creek from the tract last above described. Beginning at a Mahogany 2 xom on said Gap Creek, and running thence S. 61 E., along the line of the "Willie Pruitt home tract" 53.50 chains to a pine 3xom (down); thence N.  $9\frac{1}{2}$  to a chestnut 3xom on Bear House Ridge; thence N. 38 W., 9.00 chains to a maple 3xom on Gap Creek; near the "Winds"; thence down the said Gap Creek following the meanders thereof to the beginning corner, containing 68 acres, more or less.

(28) That tract in Glassy Mountain Township on waters of North Saluda River, containing 100 acres, more or less, being described as follows:

BEGINNING at a beech tree on Lind Cove Creek, running thence nearly South to a white oak; thence nearly Southwest to a double chestnut; thence nearly Southwest to a poplar; thence along a conditional line between the lands of Angeline Burrell and the lands of James Lindsey nearly East to a stake on the head of a branch; thence nearly East to a dead Oak on the old Grant Wheeler land; thence nearly North to a stake on the branch; thence down the said branch, following the meanders thereof, to the beech at the beginning corner.

- (29) That tract in Glassy Mountain Township on branch waters of Brushy Creek and waters of North Saluda River, containing 150 acres, more or less, adjoining lands now or formerly owned by C. A. Gosnell, Joshua Gosnell, Martin A. Neely, Mary Hipp and S. C. Dickson, and being the same tract of land conveyed to R. E. Johnston by Deed dated June, 1904, and recorded in the RMC Office for Greenville County, S. C., in Deed Volume LLL, page 791.
- (30) That tract in Glassy Mountain Township on the head waters of North Saluda River, containing 50 acres, more or less, being described as follows:
