BEGINNING at a stake in a road and running thence along the eastern line of lots in Section A as shown on plat recorded in Plat Book G at page 88, N. 4 E. 440 feet to an iron pin in NE corner of Lot 29; thence N. 1-45 W. 100 feet to an iron pin; thence N. 17-45 W. 141 feet to an iron pin in Cleveland line, N. 68 E. 367 feet to a stake; thence S. 24-40 E. 526 feet to a stake; thence S. 6-40 W. 225 feet to a stake in said road; thence with said road N. 62 W. 193.5 feet to a bend; thence S. 83 W. 160 feet to a bend; thence S. 46-30 W. 214 feet to the beginning corner.
