Benjamin P. Ponder and James G. Ponder, their Heirs and Assigns forever, All of right, title and interest in and to ALL that certain piece, parcel or tract of land situate, lying and being in the State and County aforesaid, Oneal Township, in the Washington Church community, lying on the east side of the road that leads from State Highway No. 14 to the Jordan Road, and being the same tract of land that was conveyed to Leether Ponder by deed from W. P. Gibson February 4th 1913, recorded in the office of the R. M. C. for Greenville County in Deed Book 24 at page 237, and having the following courses and distances, to wit:-

Gibson Estate; thence in a northwest course 17.50 chs. to a stake in county road; thence with the said road N. 81-00 W. 50 rods to a stake in said road; thence N. 80-00 W. 22,40 chs. to a stone in the first named road (known as the Washington Church Road); thence with this road N. 52-15 E. 19.00 chs. to the beginning corner, containing Eighty Two and 1/4 (82. 1/4) acres, more or less.
