All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the north side of Pecan Drive and being Lot No. 36 as shown on a Plat of Pecan Terrace recorded in the R.M.C. Office for Greenville County in Plat Book "GG", page 9, and being more particularly described as follows, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 35 and 36 on Pecan Drive, and running thence with the joint line of said lots N. 55-18 E. 194.9 feet to an iron pin on the rear line of Lot No. 23; thence with the rear line of Lot 23 S. 31-22 E. 33 feet to an iron pin on the rear line of Lot No. 19; thence with the rear line of said lot S. 37-51 W. 75 feet to an iron pin corner of Lot No. 37; thence with the line of Lot 37 S. 40-27 W. 109.8 feet to an iron pin on the north side of Pecan Drive; thence with said Drive N. 45-32 W. 81.6 feet to the beginning corner.
