to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Jackie Morton Gilmer, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina in that subdivision known as EASTLAKE and being known and designated as parts of Lots Nos. 17 and 18 as shown on said plat recorded in the R. M. C. Office for Greenville County in Plat Book "G", at Page 228 and described as follows.

BEGINNING at an iron pin on the northeast side of East Circle Avenue which iron pin is 15 feet South of the joint front corner of Lots Nos. 16 and 17 and running thence a new line through Lot No. 17, North 37-15 East 153.4 feet to an iron pin; said iron pin being 15 feet south of the joint rear corner of Lots Nos. 16 and 17; running thence South 53-22 East 75 feet to an iron pin; said iron pin being 30 feet from the joint rear corner of Lots Nos. 18 and 19, running thence through Lot No. 18, a new line, South 37-15 West 154.35 feet to an iron pin on East Circle Avenue; running thence along East Circle Avenue, North 52-45 West 75 feet to an iron pin, the beginning corner.

The above is the same property conveyed to the grantor by Mills H. Hughey, et al by deéd dated June 29, 1956 and recorded in the R. M. C. Office for Greenville County in Deed Book 556, at Page 287.
