KNOW ALL MEN BY THESE PRESENTS That F. W. Poe Manufacturing Company, a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of **Three Thousand Fifty and No/100ths (\$3,050.00)** ----- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

**JAMES F. HESTER AND MARGARET H. HESTER**

All that piece, parcel, or lot of land, with the improvements thereon, situate, lying, and being near the City of Greenville, Greenville County, South Carolina, and being more particularly described as Lot 66, Section 1, as shown on a plat entitled **"Revised Portion Sect. 1"** Subdivision of Village Houses, F. W. Poe Mfg. Co., Greenville, S. C., made by Dalton & Neves, **September, 1956**, and recorded in the R. M. C. Office for Greenville County in Plat Book **LL at page 113.** According to said plat, the within described lot is also known as No. 10 **Second** ~~XXXX~~ (Avenue) and fronts thereon 76 feet.

There is situate upon the above-described lot a portion of a four-car garage. By accepting this deed, the grantee agrees, and hereby binds his heirs and assigns, that he will properly maintain the portion of the garage situate on said lot, that he will not alter such portion of said garage or remove the same without the written consent of the owner or owners of the adjoining land on which the remainder of the garage is situate, and that in the event of such removal, with the consent of the adjoining owner or owners, he will construct any walls, reinforcements or other things required to make such remaining portion a complete building suitable for garage purposes.

The grantor and its predecessors in title have granted unto Parker Water and Sewer Sub-District Commission, Commissioners of Public Works of the City of Greenville, S. C., Greater Greenville Sewer District Commission, Paris Mountain Water Company, and Duke Power Company, to one or more of them and/or to others all water and sewer pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sewer lines), valves, fittings, hydrants, manholes, poles, wires, transformers, regulators, and other apparatus and equipment used in connection with, or forming a part of, the water, fire protection, electric light and power distribution, and sewerage systems of the F. W. Poe Manufacturing Company Village, in which the above described lot is located, together with rights of way and easements to go upon the land for the purpose of maintenance, repair, alteration, replacement, construction, relocation, and operation (including meter reading) of the lines and systems aforesaid and of certain other water, sewer, electric, telephone, trolley and power lines constructed or to be constructed, and to relocate certain of such lines so as to run them in, along, above or near the streets and alleyways located in the F. W. Poe Manufacturing Company Village, and to operate and maintain the lines as so relocated, all as will more fully appear by reference to the records in the R. M. C. Office for Greenville County, South Carolina.

There is excepted and excluded from this conveyance so much of the personal property above-mentioned as may be located upon the lot above described and this conveyance is made subject to the rights of way and easements above mentioned insofar as they may affect said lot.

This conveyance is made subject to the following restrictions:

- (1) That no mercantile establishment, other than those already in existence, shall be erected, operated or maintained on the lot above described.
- (2) That only one residence shall be erected or maintained on any one lot.

Together with all and singular the Rights, Members, Hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, and his (her or their) Heirs and Assigns forever.

And the said F. W. Poe Manufacturing Company does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his (her or their) heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
