TRAXLER in the State aforesaid, in consideration of the sum of FOUR THOUSAND FIVE HUNDRED AND NO/100- - - - - DOLLARS, and assumption of mortgage described below; to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said KENNETH PAUL McCALL, his heirs and assigns:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 23 on Plat of Subdivision of Elizabeth E. Voyles, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "Y", page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Echols Drive, joint front corner Lots 22 and 23, and running thence S. 21-42 E. 111.4 feet to an iron pin, joint rear corner Lots 22 and 23; thence S. 68-18 W. 90 feet to an iron pin, joint rear corner Lots 23 and 24; thence N. 21-42 W. 111.4 feet to an iron pin on the Southerly side of Echols Drive, joint front corner Lots 23 and 24; thence along the Southerly side of Echols Drive, N. 68-18 E. 90 feet to an iron pin, the point of beginning.
