Taylor, his heirs and assigns, forever.

All that certain piece, parcel or lot of land with the improvements thereon; lying, being and situate in the County of Greenville, State of South Carolina, Fairview Township on State Highway S-23-162 leading from U. S. Highway 276 to Bryson High School. This being property known and designated as Lot No. 14 on the eastern side of said road according to a plat made by Lewis C. Godsey, Reg. L. S., dated September 9, 1955 for a subdivision known as Evergreen Park. Said lot being in Block B of said plat and being more fully described according to said plat which is recorded in the R. M. C.
