

That I, Thomas W. Miller, in the State aforesaid, in consideration of the sum of One Thousand Five Hundred (\$1,500.00)----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. Cooper Shackelford, the following described property, to-wit:

The northeasterly one-half of the front portion of Lot No. 12 on the northern side of Sirrine Drive as shown on the plat of property of L. A. Mills made by R. E. Dalton in March, 1925, recorded in Plat Book J, at page 29, and described as follows:

BEGINNING At an iron pin on the north side of Sirrine Drive at the corner of Lots Nos. 12 and 13 (in line of other property of grantee), said pin being 200 feet west from the intersection of Sirrine Drive and Ridge Drive (now Byrd Boulevard) and thence along the line of other property of the grantee, being the rear line of Lots Nos. 13, 14 and part of 15, N. 25-28 W. 170 feet to an iron pin; thence across Lot No. 12, S. 64-32 W. 38.55 feet; thence S. 25-28 E. 170.8 feet to a point on the north side of Sirrine Drive; thence with the north side of Sirrine Drive, N. 6k-32 E. 38.55 feet to the beginning.

This being the northeasterly one-half of one of the parcels of property conveyed to the grantor by Virginia P. Bannon by deed dated December 30, 1944, recorded in the office of the R. M. C. for Greenville County in Deed Book 270, page 352.

Grantee agrees for himself and his heirs and assigns, that he will not sell or voluntarily dispose of the above described property for a period of five years without offering to the grantor a first option to purchase the same for the sum of \$1,500.00. Provided, however, that if the grantee constructs any building improvements on the said tract, then this limitation α condition will no longer be effective.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, Heirs and Assigns forever. and

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
