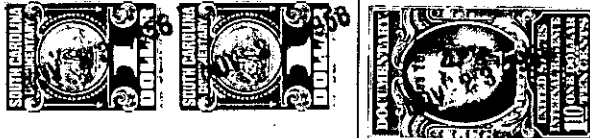
All that piece, parcel or lot of land located in Gantt Township, Greenville County, in subdivision off White Horse Road known as White Horse Addition according to plat made by J. C. Hill, May 15, 1951 recorded in R. M. C. Office for Greenville County in Plat Book "W" page 187, said lot being number 6 and number 7, and being more particularly described as follows:

BEGINNING at an iron pin on the east side of Evelyn Drive, at the joint front corners of lots 5 and 6; thence S. 30-45 E. 229 feet to an iron pin on Evelyn Drive, which iron pin is in a branch; thence following along the meanderings of the branch, 321 feet more or less to an iron pin; thence continuing along said branch, 132 feet more or less to an iron pin, which iron pin is at the joint rear corners of lots 5 and 6; thence S. 59-15 W. 345.2 feet to an iron pin on Evelyn Drive, the point of beginning.

Restrictions:

- 1. No residence is to cost less than \$4000.00 and no residence shall be erected on said lot nearer than 50 feet to the front line.
2. No outside toilets are permitted and sewage is to be disposed of by approved septic tanks.
