

Leisenring, in consideration of the sum of Four Thousand Nine Hundred Ninety-six & 64/100------DOLLARS, (\$4,996.64) and assumption of mortgage hereinafter referred to, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Edwin H. Martinat and Martha Jean Y. Martinat ALL That lot of land with the buildings and improvements thereon situate, on the North side of Dellwood Drive in the City of Greenville, County of Greenville, being shown as Lot 5 on plat of C. A. Harvin, Jr. and J. K. Buff, made by Dalton & Neves, Engineers, August 1952, recorded in the R.M.C. office for Greenville County, S. C. in Plat Book CC at Page 143, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the north side of Dellwood Drive at joint corner of Lots Nos. 5 and 39 and running thence with the line of Lot No. 39, N. 5-32 E. 161.5 feet to an iron pin; thence N. 50-41 W. 100 feet to an iron pin on the southeast side of Alpine Way; thence with the southeast side of Alpine Way, S. 39-19 W. 180 feet to an iron pin; thence with the curve of Alpine Way and Dellwood Drive (the chord being S. 21-35 E. 70 feet) to an iron pin on the north side of Dellwood Drive; thence with the north side of Dellwood Drive, S. 82-28 E. 151 feet to the beginning corner.

This is the same property conveyed to the grantors herein by deed of Donald D. Deming dated November 4, 1955, recorded in the R.M.C. office for Greenville County, S. C. on November 22, 1955, in Deed Book 539, at Page 303.

As part of the consideration for this deed, grantees assume and agree to pay that certain mortgage from the grantors herein to C. Douglas Wilson & Co., recorded in the Office of the R. M. C. for Greenville County, S. C. in R.E.M. Book 659, at Page 377, on which there is a balance due of \$12,003.36.
