Curry her Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township, and in the Town of Fountain Inn on the North or Northwestern side of N. Weston Street, known and designated as Lot No. 4 of the L. R. Gault property, with the following metes and bounds, to-wit: Beginning at an iron pin, joint front corner with Lot No. 3 this day conveyed to Ann G. Straughan, on N. Weston Street, running thence with said Street N. 37 E. 90 feet to an iron pin, joint front corner of Lot No. 5 on said Street, said Lot No. 5 being this day conveyed to Wilma G. Barnhardt; thence with the joint line of said Lot No. 5 N. 54 W. 150 feet to an iron pin, back joint corner with said Lot 5 on line of other land of the Grantor; thence with joint line of land of the Grantor S. 37 W. 90 feet to an iron pin, back joint corner with Lot No. 3; thence with the joint line of Lot No. 3 S. 54 E. 150 feet to an iron pin on N. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
