to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. K. Ellis and Dorothy W. Ellis, their heirs and assigns forever:

All that lot of land lying in Paris Mountain Township, County of Greenville, State of South Carolina, on the southwest side of New Buncombe Road (known as Highway 25) and being shown as the major portion of Lot No. 4 on a plat of the property of Harriet H. Parker prepared by Dalton & Neves dated November, 1939, recorded in Plat Book J at Pages 142-143, being more particularly shown on a plat of the property of John H. Parkins and Mary M. Parkins prepared by C. C. Jones dated August 20, 1956, and according to said plat having the following metes and bounds:



BEGINNING at an iron pin on the southwestern side of New Buncombe Road at the front corner of Lot No. 3; running thence with the line of said lot S.26-15 E. 442 feet to an iron pin; thence through Lot No. 4 S. 38-51 E. 150.2 feet to an iron pin in the line of Lot No. 5; thence with the line of said lot N. 26-15 E. 442.4 feet to iron pin on the southwestern side of New Buncombe Road; thence with the southwestern side of said road N. 39-03 W. 150 feet to an iron pin at beginning corner.

This being the major portion of property which was conveyed to the grantors by deed of Mark P. Jackson, Jr., recorded in Deed Book 365 at Page 148.



As a part of the consideration for this deed the grantees assume and agree to pay a balance of \$4141.23 on a mortgage held by Metropolitan Life Insurance Company recorded in Book of Mortgages 354 at Page 192.
