to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bertha P. Wells, her heirs and assigns forever:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, situate, lying and being on the western side of Long Hill Street in the City of Greenville, being shown as part of Lot 87 and part of Lot 85 on a revised plat of Augusta Road Ranches recorded in Plat Book M at Page 47, that portion of Lot 87 also being shown as parcel A on plat made by Pickell & Pickell recorded in Plat Book R at Page 55, and when described together have the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Long Hill Street and joint corner of Parcels A and B which point is 168.8 feet in a southeasterly direction from the intersection of Henrietta Avenue and Long Hill Street and running thence along the joint line of Parcels A and B (through Lot 87) S. 24-29 W. 143.3 feet to an iron pin in line of Lot 86; thence with the line of Lot 86 and 87 S. 3-53 E. 117 feet to an iron pin at corner of Lot 85; thence along the joint rear line of Lots 86 and 85 S. 50-40 W. 86.1 feet to an iron pin; thence N. 89-47 E. 213.6 feet to an iron pin on western side of Long Hill Street; thence along the western side of Long Hill Street N. 6-01 W. 46 feet to an iron pin at the joint corner of Lots 85 and 87; thence continuing with Long Hill Street N. 29-39 W. 12 feet to the point of beginning.
